Meeting called to order by Fred Wachter at 7:30 PM

- Miscellaneous Comments – Fred Wachter
  - Substitutions
    - Subs can be substituted **ONLY**:
      - Their throw-in
      - Their corner kick
      - Any goal kick
      - Any goal scored
    - Subs **CANNOT** be allowed on dead ball fouls (free kicks)
    - Other team can substitute on an opponent's substitution if present at bench with other team there
  - We stop the clock on:
    - Goal scored
    - Injury
    - Penalty kick
    - Or when you deem team is intentionally stalling
      - **WE DO NOT ADD TIME!**
  - There is no such play where an offensive team is awarded a direct free kick inside the penalty area
    - This can only be a penalty kick
  - Bench clearing brawl
    - **DO NOT** try to separate combatants (liability issue for Official)
      - Officials should note who is involved
        - Note who is leaving bench (Red card)
          - Refer to rule book: PR 12.8.3 Situation G (pg. 58)
    - If you choose to terminate/suspend the match because of an altercation
      - You **MUST** send a **DETAILED** report of the altercation and reason for termination/suspension of play to Tom Cully and BOCES
  - Modified Rules
    - Section VIII (Nassau County) has mandated that Goalies **MUST WEAR SOFT HELMETS**
      - This supersedes the NYS's modified rules
      - Goalies **MUST** have a soft helmet, mouth guard and chin strap
    - See website for complete (updated) modified rules
    - Do not let coaches discuss issues of game control with you while they should be attending to an injured player
      - Once the coach/trainer comes on field, step away from injured player

- Goals must be anchored
- Miscellaneous Comments – Bob Signoracci

    - Cantiague Park, 7v7
  - If you give a card
    - Stop the clock
    - Beckon the player over, show card over your head
    - Tell scorekeeper, each coach and your partner who and what the foul was
